RESOLUTION OF COUNCIL ESTABLISHING FEES

RESOLUTION OF COUNCIL REVISING AND ESTABLISHING FEES TO BE ASSESSED AND SET FORTH IN CITY CODE BOOK "APPENDIX A" REGARDING FEES FOR PERMITS AND INSPECTIONS UNDER TITLE 9 OF THE CITY CODE.

WHEREAS, the City Council for the City of Pryor Creek, Oklahoma has previously established by resolution certain fees for permits and inspections under Title 9 of the City Code.

WHEREAS, the City Council has reviewed the fees as previously set forth in comparison to those charged by similar cities in the same geographic area as the City and taken into consideration the costs involved to the city regarding the processes of same.

WHEREAS, the City Council as the governing body of the City is charged with the responsibility and vested with the authority to set the fees and costs of permitting and inspections related to building code matters deemed by the Council to be fair, reasonable and in the best interests of the public and the City.

NOW THEREFORE BE IT RESOLVED, that the City Council of the City of Pryor Creek, Oklahoma directs the fees regarding permits and inspections issued under Title 9 of the City Code shall hereby be revised and modified and shall be as follows, to be noted and added to the schedule of fees and costs in Appendix "A" of the City Code Book: **(deletions to existing ordinance stricken, additions underlined)**
