MINUTES CITY COUNCIL MEETING FOLLOWED BY PRYOR PUBLIC WORKS AUTHORITY MEETING CITY OF PRYOR CREEK, OKLAHOMA TUESDAY, MARCH 5TH, 2024 AT 6:00 P.M.

The City Council of the City of Pryor Creek, Oklahoma met in regular session on the above date and time in the Council Chamber upstairs at City Hall, 12 North Rowe Street in Pryor Creek, Oklahoma. This meeting was followed immediately by a meeting of the Pryor Public Works Authority. Notice of these meetings was posted on the East bulletin board located outside to the South of the entrance doors and the City website at www.pryorcreek.org. Notice was also emailed to The Paper newspaper and emailed to the Council members.

1. CALL TO ORDER, PRAYER, PLEDGE OF ALLEGIANCE, ROLL CALL.

Mayor Doyle called the meeting to order at 6:01 p.m. The Prayer and Pledge of Allegiance were led by Terry Lamar. Roll Call was conducted by City Clerk Courtney Davis. Council members present included Terry Lamar, Choya Shropshire, Lori Bradshaw, Travis Mileur, Randy Chitwood, Charles Tramel, Chris Gonthier and Bruce Smith. Members absent: none.

Department Heads and other City Officials present: Chase McBride, Jeremy Cantrell, Justin Couch, Kevin Tramel, Becki Sams-Benham, BK Young, Mike Moore, Frank Powell, Buddy Glenn, Dennis Bowman and Cari Rerat.

Others present: Gilbert Graybill, Autumn Graybill, Angela Smith, Kemmie Shropshire, Ginger Upshaw, Martin Miller, Nena Roberts, Marshel Morrison, Adam Anderson, Drew Stott, Tyler Brown, Kenneth Brashears and Terry Aylward.

2. PETITIONS FROM THE AUDIENCE:

(Limited to 5 minutes, must request in advance.) There were no petitions from the audience.

3. DEPARTMENT HEAD REPORTS. a. Building Inspector

No report.

b. Emergency Management

No report.

c. Fire

Young reported that his department is doing well handling an increase in calls although they are needing more volunteer firefighters. He stated that they are reviewing their administrative procedures to better service the full district.

d. Golf

Bowman reported that his department is preparing for the mowing season. He also stated that they have many upcoming tournaments.

e. Library

Rerat provided statistics showing that Library demand has slightly increased since last month. She reported that Thunderbird students have resumed making regular visits as a group. She also stated that they are preparing for an escape room and a fundraiser in April as well as the Summer reading program later this year. She stated that the Library is currently short one staff member and she believes two more will be leaving soon.

f. Parks / Cemetery

Powell reported that they are working to prepare the skate park. He stated that they are also preparing to open splash pad and bathrooms. Powell also stated that the park is doing well for staff but the Cemetery will be short one employee in June and they will be needing temporary employees to get through the summer.

g. Police / Animal Shelter

Cantrell reported that there were 1,673 calls, 700 traffic stops and 202 citations written in February. He stated that Citizen's Police Academy has begun its second class. Cantrell also reported that they collected \$43,000.00 through the firearms auction.

Cantrell stated that they are down two officers and expect to lose several more to transfers or retirement. He explained that new officers can take up to a year to be hired on and fully trained for the position.

Sams-Benham reported that the shelter took in 52 animals last month and had 52 outgoing animals. She also reported that they are working to start some repairs on the fence and the kitchen area.

h. Recreation Center

Moore reported that they have replaced two HVAC units and the pool pump motor. He stated that they have hosted 144 public pool parties and 52 private pool parties. He also stated that they are now offering a line dancing class and will be hosting a volleyball skills camp in April. Moore reported that they will need to replace some temporary employees soon.

i. Street

Glenn reported that they have been working on many asphalt repairs around the city, including areas of South Adair, NW 5th, Graham and NE 3rd. He stated that they have dipped around 1,600 feet of ditches and replaced a drain pipe at SE 8th and Adair. He also reported that they continue to work on repairs to the street sweeper.

Glenn stated that his department currently has ten employees but he will be needing help with the expected increase in workload following the annexation and the additional highway maintenance the state has left to the City.

j. City Clerk

Davis reported that financials for January were closed today. She stated that her office staff are working hard to cover shortages but she is in need of two employees, including one to fill the vacant deputy court clerk position. She also stated that she is working to improve processes for community development and financial reports.

Davis also reported that new technologies are being integrated with the city. She stated she is working with the Police Department to implement digitickets and has distributed new tablets to Council members.

This Agreement is made and entered into this ______ day of ______, 20____, by and between the Cherokee Nation Election Commission, P.O. Box 1188, Tahlequah, Oklahoma 74465 (hereinafter referred to as the "Election Commission"), and _______, Address: ______, Tax Identification Number: (hereinafter referred to as "FACILITY").

WHEREAS, the Election Commission wishes to enter into an Agreement with the FACILITY to have access and use of the building commonly known as ______ (hereinafter referred to as the "Premises"), to serve as a polling location to conduct elections for the Cherokee Nation, and

WHEREAS, the FACILITY hereby affirms it is an independent organization in accordance with the laws of the State of Oklahoma and the Internal Revenue Service, and

NOW THEREFORE, and in consideration of the mutual covenants, promises, agreements, understandings, and conditions herein contained, the parties hereto mutually promise to the other, agree, and understand as follows, to wit:

TERM: The term of this Agreement shall be for June 15, 2024, Special Election, unless canceled or extended in writing by the parties hereto.

PERFORMANCE REQUIREMENTS OF THE ELECTION COMMISSION:

- 1. The Election Commission shall conduct a Special Election, on June 15, 2024, for the Cherokee Nation at the Premises.
- 2. The Election Commission shall be responsible for sweeping and/or cleaning the Premises after each use to ensure the Premises is left in a clean orderly condition.

PERFORMACE REQUIREMENTS OF THE FACILITY:

The FACILITY shall provide access to the Premises between the hours of ______a.m. and _____p.m. in order for the Election Commission to conduct the Special Election. Keys issued for access to the Premises will not be duplicated and shall be issued only to authorized personnel of the Election Commission.

ASSURANCES:

- 1. This Agreement shall be governed by, construed, and enforced in accordance with the laws of the United States and where applicable, the laws of the Cherokee Nation. If it should appear that any of the Agreement terms are in conflict with any rule of law or statutory provision of the United States, or where applicable, with any rule of law or statutory provision of the Cherokee Nation, such conflicting term(s) shall be deemed inoperative and null and void insofar as it may be in conflict with such rule of law or statutory provision, and shall be deemed modified to conform to such rule of law or statutory provision. However, such conflict shall not operate to nullify or void the entire agreement.
- 2. This Agreement contains the complete expression of the parties' agreement with respect to the subject matter hereof, and shall bind the parties, their successors and assigns. There are no previous or contemporary understandings, representations, or warranties not set forth herein. No subsequent amendment or modification of this Agreement shall be of any force or effect unless in writing and signed by the parties to be bound thereby. No provision of this Agreement shall be considered waived by the Election Commission unless such waiver is in writing and signed by the Election Commission. No such waiver shall be a waiver of any past or future default, breach, or modification of any of the provisions of the Agreement unless expressly stipulated in such waiver. The parties' further state to the best of their knowledge, no employee of the Election Commission who exercises any functions or responsibilities in connection with the performance hereunder has any personal interest, direct or indirect, in this Agreement. This Agreement shall supersede any and all written or oral statements, agreements, and/or representations of the parties made prior to or contemporaneously with the execution hereof. The parties agree their respective performances hereunder shall be governed by an obligation of good faith.
- 3. The Agreement may be terminated or canceled by either party upon thirty (30) days written notice of intention to the authorized representatives of each party signed below.

- 4. The parties hereby agree the services specified in this Agreement may not be delegated or assigned without the prior written approval of the Election Commission.
- 5. This Agreement shall not be construed to constitute a joint venture, partnership, nor other form of agreement creating a joint liability between the parties. Each party shall be responsible and liable for the acts and omissions of its respective agents and employees.
- 6. The FACILITY shall not be liable for any injury or loss arising out of the sets or omissions of the Election Commission, or its employees, agents, or representatives, unless such injury or loss should result, directly or indirectly, from the negligent or deliberate acts or omissions of the FACILITY, its employees, agents, or representatives.
- 7. The Cherokee Nation is a sovereign nation and enjoys the full privileges of a sovereign's immunity from suit, as recognized by Congress and the United States Supreme Court Execution of this Agreement shall not be construed to be a waiver of sovereign immunity, and neither shall any clause herein be construed to effectuate the consent to suit, as the Cherokee Nation expressly declines to waive sovereign immunity.

CONSIDERATION AND COMPENSATION:

The Parties hereby agree there will be a charge of \$______ for the use of the Premises for <u>each</u> Election. This Agreement shall not exceed \$______ without prior written consent of the Election Commission.

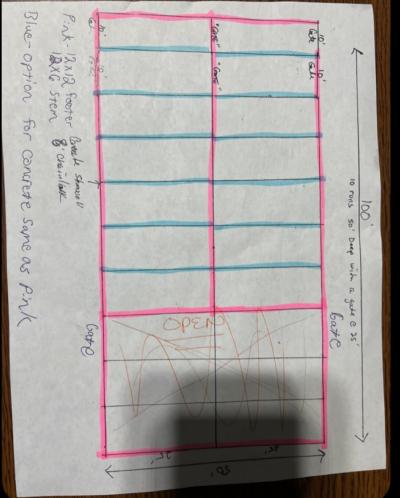

Dear Mayor Doyle and the City Council;

I am contacting you and the City of Pryor's City Council asking for financial assistance for the Sertoma Senior Citizens Center located in the City's building at 225 S Rowe for the upcoming 12 months.

The Sertoma Senior Citizens Center has been active since the 1970's. Our Mission Statement says, "We are a service to mankind center serving our senior citizens needs to the best of our ability." We serve our seniors with meals and free van transportation. Other social activities at the center include a pool table or snooker table, board games, bingo, and bunko games regularly. We have nurses that come by monthly to take blood pressure and blood sugar readings. You can see our regular postings of activities and lunch menus on the Facebook page of the Sertoma Club of Pryor Creek.

We provide free van transportation around the city limits of Pryor every weekday and provide lunch meals on Tuesdays and Fridays. We ask for meal donations in the amount of \$5 and \$3 for those older than 50 years. We deliver these meals to our homebound seniors as well.

In 2023 we served 4730 meals and provided 3105 free van rides. We have 3 part-time employees, Gloria Kelsey is our cook, Leroy Linam is our van driver, and Toni Pullie, office manager. Cost savings measures have been initiated. Our employees agreed to work less than a 40 hour week. We have reduced phone line costs and internet costs.

We do receive other assistance from the United Way of Rogers and Mayes Counties of \$10,000 per year and Northeast OK Rural Electric Round-up program of \$4000/year. The income from meals is projected at \$11,300 per year. Since the remodel of the Sertoma building rent income continues to improve and we project that at \$9,500/year. Our projected needs are \$70,800 per year or \$5,900/month which include wages, food costs, fuel for van, insurance, phone/internet, and other various costs.

The Mayor asked me to include a Projected Budget for the next 12 months for the Senior Center to determine what the need is. Please find the budget attached on page 2.

According to the projected budget our need or request for the next 12 months from the City is \$36,000.

ORDINANCE NO.

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF A PART OF THE SOUTHWEST QUARTER (SW/4) OF SECTION 31, TOWNSHIP 21 NORTH, RANGE 19 EAST OF THE INDIAN BASE AND MERIDIAN, MAYES COUNTY, OKLAHOMA INTO THE CORPORATE LIMITS OF THE CITY OF PRYOR CREEK, OKLAHOMA; PROVIDING THAT THE NEWLY ANNEXED TERRITOR4Y BE ZONED "RM" (RESIDIENTAL MULTI-FAMILY); AND PROVIDING FOR REPEALER AND SEVERABILITY.

COMING BEFORE the City Council for the City of Pryor Creek, Oklahoma, is the Petition for Annexation filed by PCO Holdings, LLC (herein PCO) in reference to the following:

SECTION 1: JURISDICTIONAL FACTS

A Petition for Annexation was filed with the City of Pryor Creek, Oklahoma on the 31st day of January 2024 by PCO. In said Petition for Annexation, PCO, requested that the City of Pryor Creek add the following described property into the corporate limits of the City:

A tract of land situated in the Southwest Quarter (SW/4) Section 31, Township 21 North, Range 19 East of the Indian Base and Meridian, Mayes County, Oklahoma, being more particularly described as follows to-wit:

Notice of the presentation of said Petition for Annexation was published at least once each week for two (2) successive weeks in a newspaper of general circulation in the City of Pryor Creek. The Petitioner, PCO, by way of its Petition for Annexation has properly requested and consented to the annexation of the above described territory to the City. The territory petitioned to be annexed is adjacent and contiguous to the City of Pryor Creek. The territory to be annexed is wholly owned by PCO and PCO is therefore the owner of all the value of the property comprising the territory proposed to be annexed.

The City of Pryor Creek finds that said property is adjacent and contiguous to the corporate limits of the City of Pryor Creek, is not part of any other incorporated municipality, and is owned by PCO. The City of Pryor Creek further finds that the notices published fully comply with Oklahoma law as to the form, giving notice that said Petition had been presented, setting forth the nature and purpose of said Petition, describing the property sought to be annexed, and reciting that the Petition was signed by the owner of the property sought to be annexed. Commencing at the Southwest Corner of said SW/4, THENCE North 88°28'26" East for a distance of 1162.71 feet along the South line of said SW/4; THENCE North 88°25'43" East for a distance of 999.72 feet along said South Line; THENCE North 1°34'176" West for a distance of 240.50 feet to the POINT OF BEGINNING; THENCE South 88°25'43" West for a distance of 877.10 feet; THENCE North 1°34'17" West for a distance of 158.49 feet; THENCE north 59°12'09" East for a distance of 823.28 feet; THENCE South 30°50'53" East for a distance of 157.63 feet; THENCE North 88°26'15" East for a distance of 81.53 feet; THENCE South 1°34'17" East for a distance of 422.96 feet to the POINT OF BEGINNING. (Containing 7.5911 acres more or less)

And that the official zoning map of the City of Pryor Creek, Oklahoma, shall be amended to reflect the change in the boundaries resulting from this annexation. The Mayor is hereby authorized and directed to file and record a duly certified copy of this Ordinance, together with an accurate map or plat of the annexed property, in the office of the Mayes County Clerk and with the Ad Valorem Division of the Oklahoma Tax Commission, and to take appropriate measures to implement this Ordinance.

SECTION 3: ZONING

BE IT FURTHER ORDAINED BY THE CITY COUNCIL FOR THE CITY OF PRYOR CREEK, OKLAHOMA that pursuant to Section 10-1-10E of the Code of Ordinances of the City of Pryor Creek, Oklahoma providing for the assignment of the zoning classification to territory annexed to the City, that the following described tract of land newly annexed into the City of Pryor Creek, Oklahoma is hereby classified as "RM" (Residential Multi-Family), to-wit: A tract of land situated in the Southwest Quarter (SW/4) Section 31, Township 21 North, Range 19 East of the Indian Base and Meridian, Mayes County, Oklahoma, being more particularly described as follows towit:

Commencing at the Southwest Corner of said SW/4, THENCE North 88⁰28'26" East for a distance of 1162.71 feet along the South line of said SW/4; THENCE North 88⁰25'43" East for a distance of 999.72 feet along said South Line; THENCE North 1⁰34'176" West for a distance of 240.50 feet to the POINT OF BEGINNING; THENCE South 88⁰25'43" West for a distance of 877.10 feet; THENCE North 1⁰34'17" West for a distance of 158.49 feet; THENCE north 59⁰12'09" East for a distance of 823.28 feet; THENCE South 30⁰50'53" East for a distance of 157.63 feet; THENCE North 88⁰26'15" East for a distance of 81.53 feet; THENCE South 1⁰34'17" East for a distance of 422.96 feet to the POINT OF BEGINNING. (Containing 7.5911 acres more or less)

And that the Official Zoning Map of the City of Pryor Creek, Oklahoma, shall be amended to reflect the establishment of zoning of the annexed territory as reflected in Section 3 of this ordinance.

SECTION 4: REPEALER

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of any such conflict.

SECTION 5: SEVERABILITY

If any section, sub-section, sentence, clause, phrase, or portion of this Ordinance is, for any reason, held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portion of this ordinance.
