Dear Board Members:

The subject property has a current zoning of AG (Agriculture). The property applicant is requesting re-zoning to C A/R (Commercial Automotive/Retail).

C A/R zoning is used in Pryor as the general designation for retail commercial properties along major highway properties from N-S on Hwy 69 and E-W for Hwy 20 and along NE 1st Street extended east (Old Highway 20). The C A/R designation has extended east along NE 1st St. to properties fronting onto NE 1st St. on the south side of the street. The subject property also fronts onto NE 1st St. in the immediate area as other same zoned tracts and being the first property so requesting such designation on the north side of NE 1st St. of C A/R zoning.

Property on either side of this tract of land continues to be zoned AG. AG zoning is basically a “holding” zoning until development in the area occurs and thus allows orderly progression of more restrictive zoning as land area moves outward from the City corps areas.


The re-zoning this property will provide the continuation and extension of commercial General and specifically C A/R zoning to this identified commercial corridor.

This meeting was followed immediately by a meeting of the Pryor Public Works Authority. 1. CALL TO ORDER, PRAYER, PLEDGE OF ALLEGIANCE, ROLL CALL.

Mayor Lees called the meeting to order at 6:00 p.m. The Prayer and Pledge of Allegiance were led by Jon Ketcher. Roll Call was conducted by City Clerk Eva Smith. Recommendation

If a basic car port design is desired then option A is recommended. But we recommend option C which is a cantilever-based option to offer more flare and to look as if it was originally designed for the structure and not an add on. Recommendation for this would be to change the columns to be vertical rather than have an angled base because these columns would be parallel to the blue accent wall but adjacent to the brick wall of the structure. This would allow for a more enjoyable view coming from the road way seeing vertical columns in front of the colonnade before the blue accent wall begins on the West side. Another option for the columns to make it more aesthetically pleasing would be to do a column wrap with brick to match the brick of the structure and of the colonnade. This wrap would go all the way around the columns and would be about 4 feet high.

If the City of Pryor Creek chooses to proceed with the closure, the city will assume all responsibilities for the traffic control to be installed according to the Manual on Uniform Traffic Control Devices (MUTCD), a detour that is feasible for both passenger and commercial truck traffic, the effect on emergency responses and all other associated liabilities.

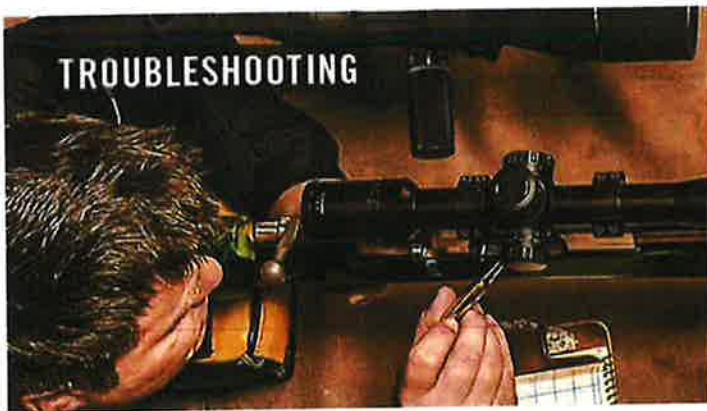
