THE PRYOR ECONOMIC DEVELOPMENT TRUST AUTHORITY MET IN REGULAR SESSION IN THE CITY COUNCIL CHAMBER, 12 NORTH ROWE STREET, PRYOR, OKLAHOMA AT THE ABOVE DATE AND TIME.

1. CALL TO ORDER, PRAYER, PLEDGE OF ALLEGIANCE - MR. ANDERSON.

The meeting was called to order by Adam Anderson at 12:00 p.m. Prayer and Pledge of Allegiance were led by Darrell Moore. Members present: Anderson, Derr, Moore, Sordahl, Miller. Members absent: Berger and Williams.

Others in attendance: Mayor Lees, Jared Crisp, Kim Ritchie, Jennie LaFave, Meredith Olson, Casie Summerlin, Barbara Hawkins, Jill Sherman and Terry Aylward.

2. APPROVE MINUTES FROM THE SEPTEMBER 19, 2022 SPECIAL MEETING.

Motion was made by Moore, second by Derr to approve minutes from the September 19, 2022 special meeting. Voting yes: Sordahl, Derr, Moore, Miller, Anderson. Voting no: none.

3. PETITIONS FROM THE AUDIENCE.

There were no petitions.

4. DISCUSS, POSSIBLY RECOMMEND COUNCIL ACTION REGARDING APPROVAL OF 2023 EDTA MEETING SCHEDULE.

Motion was made by Moore, second by Sordahl to recommend Council action regarding approval of 2023 EDTA Meeting Schedule. Voting yes: Derr, Moore, Miller, Anderson, Sordahl. Voting no: none.

Anderson moved to Item 6.

Williams arrived at 12:08 p.m.

6. REPORT FROM PRYOR MAIN STREET DIRECTOR, JENNIE LAFAVE.

LaFave spoke briefly and reported that she met with the National Main Street Organization last week.

7. DISCUSS, POSSIBLY RECOMMEND COUNCIL ACTION REGARDING APPROVAL OF A MEMORANDUM OF UNDERSTANDING WITH PRYOR MAIN STREET.

Motion was made by Moore, second by Derr to table this item until next month.

Sordahl and others stated that they had a few questions. Sordahl and Mayor agree that this should be reviewed by the Bond Counsel. Ritchie stated that he tailored this MOU to the bond language, but he agrees it would be good for the Counsel to review it. Sordahl requested specifics on what the monies will be used for.

Ritchie requested the Pryor Main Street bylaws and organization documents from LaFave for his review. It was agreed that Pryor Main Street should be independently audited annually.

It was agreed that the EDTA should read through this document carefully and send any and all questions to Darla Coats by November 1st, for Mr. Ritchie to review before the next meeting.

Barbara Hawkins arrived at 12:10 p.m.

Anderson moved back to Item 5.

5. REPORT FROM PRYOR AREA CHAMBER OF COMMERCE PRESIDENT, BARBARA HAWKINS.

Hawkins reported that they have been working mostly on tourism. They are also working closely with the local liquor stores to get on the ballot to be able to open on Sundays. She also reported that they are working on Halloween and the Christmas Parade.

Hawkins reported that there is a family who has a collection of over 400 nativity scenes and they are planning a pop-up museum to display them throughout the holiday season.

8. REVIEW OF FINANCIAL REPORT, MAYOR LEES.

Mayor reported that the balance in the EDTA fund is currently \$134,142.21.

It was stated that only two of the sports organizations have applied for and been awarded grants at this point, each in the amount of \$5,000.00.

9. ECONOMIC DEVELOPMENT UPDATES - MAYOR LEES, MUB GM JARED CRISP.

Mayor reported that the Outdoor Fitness Court will be opened at the Recreation Center this Friday, October 21st. The Meadows building project is moving forward. Planning and design for the EFE Access Group grocery store and green space is coming along. The Police / Fire and Library projects should be ready for occupancy in early November.

Crisp reported:

- 1. We have a lot of infill in town, which is really good.
- 2. There will be an ice rink this holiday season at The District.
- 3. GRDA has hired a new Economic Development Planner, who would like to meet with city entities soon. Crisp is working to set up a meeting with him.
- 4. Laura Townsend with GRDA is retiring at the end of the year.

10. UNFORESEEABLE BUSINESS.

There was no unforeseeable business.

ORDINANCE NO. 2018-19

AN ORDINANCE OF THE CITY OF PRYOR CREEK, OKLAHOMA (THE "CITY"), AMENDING ORDINANCE NO. 2011-1 OF THE CITY BY PROVIDING FOR THE EXTENSION OF THE TERMINATION DATE OF A ONE TWENTIETH OF ONE PERCENT (.05%) EXCISE TAX (SALES TAX) WHICH REPRESENTS A PORTION OF AN EXISTING CITY EXCISE TAX (SALES TAX) OF ONE-HALF OF ONE PERCENT (0.50%) AND MODIFYING THE PURPOSE OF REVENUES OF SAID TAX; PROVIDING FOR THE EFFECTIVE DATE; PROVIDING THAT THE BALANCE OF ORDINANCE NO. 2011-1 REMAINS UNCHANGED; PROVIDING THAT THE PROVISIONS OF THIS ORDINANCE ARE CUMULATIVE AND IN ADDITION TO ANY AND ALL TAXING PROVISIONS OF OTHER CITY ORDINANCES; PROVIDING FOR SEVERABILITY OF PROVISIONS; AND CONTAINING OTHER PROVISIONS RELATED THERETO.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PRYOR CREEK, OKLAHOMA, AS FOLLOWS:

<u>Section 1</u>. <u>Citations and Codification</u>. This Ordinance shall be known and may be cited as the City of Pryor Creek Economic Development Sales Tax Ordinance of 2019, and the same shall be codified and incorporated into the Code of Ordinances of the City of Pryor Creek, Oklahoma.

<u>Section 2</u>. <u>Amendment to Section 6 of Ordinance 2011-1</u>. Section 6 of Ordinance No. 2011-1 currently reads as follows:

"SECTION 6. EFFECTIVE DATE AND TERMINATION. This Ordinance and the tax herein levied shall become and be effective on the later of (1) the termination date of the existing one-half of one percent sales tax levied and assessed under Ordinance No. 2002-1, or (2) October 1, 2011, subject to approval of a majority of the registered voters of the City of Pryor Creek, Oklahoma, voting on the same in the manner prescribed by Title 11, Oklahoma Statutes 2001, Section 16-101 et seq., as amended; provided, that upon approval by the voters as aforesaid, this Ordinance shall remain in effect until revenues from the tax herein levied are sufficient to retire all indebtedness incurring for the purpose set forth in Section 7 hereof, but in no event later than fifteen (15) years from the effective date of such tax."

Said Section 6 of Ordinance No. 2011-1 is hereby amended to read as follows:

"SECTION 6. EFFECTIVE DATE AND TERMINATION. The collection of one twentieth of one percent (.05%) excise tax which represents a portion of an existing City excise tax of one-half of one percent (0.50%) shall become effective on the later of (1) the termination date of the existing one-half of one percent sales tax levied and assessed under Ordinance No. 2002-1, or (2) October 1, 2011, and shall terminate and said excise tax shall not be collected after September 30, 2034, subject to approval by a majority of the qualified electors of the City voting on the same in the manner prescribed by law."

<u>Section 3</u>. <u>Amendment to Section 7 of Ordinance 2011-1</u>. Section 7 of Ordinance No. 2011-1 currently reads as follows:

"SECTION 7. PURPOSE. It is hereby declared to be the purpose of this Ordinance to provide revenues to be placed in a separate, special fund to be expended as follows: (1) constructing and improving streets and related drainage facilities and utility relocations; (2) construct, equip and furnish a new city hall; and (3) repairing, refurbishing, and equipping the existing municipal recreation center; and/or for the payment of principal and interest on any indebtedness, including refunding indebtedness, incurred by or on behalf of the City of Pryor Creek, Oklahoma for such purposes."

Said Section 7 of Ordinance No. 2011-1 is hereby amended to read as follows:

"SECTION 7. PURPOSE. It is hereby declared to be the purpose of this Ordinance to provide revenues from a one twentieth of one percent (.05%) excise tax to be used to create new jobs and retain existing jobs in the Main Street Corridor of the City of Pryor Creek, Oklahoma, by paying the costs incidental to and/or debt service on obligations issued to assist in the establishment of business and/or commercial facilities to be owned or used by said businesses or commercial entities or the City or public trusts having the City as beneficiary, said sales tax to be made available and expended for the above purposes for no consideration other than the economic benefit to be provided to the citizens of the City by the establishment of said facilities and by the creation of new jobs, as will be further specified in an agreement(s) to be negotiated."

<u>Section 4</u>. <u>Effective Date</u>. The provisions of this Ordinance shall become effective on and after March 5, 2019, subject to approval by a majority of the qualified electors of the City voting on the same in the manner prescribed by law.

<u>Section 5</u>. <u>Remainder of Ordinance No. 2011-1 Unchanged</u>. Except as amended in Section 2 and Section 3 hereof or other Ordinances approved by the City, the remaining provisions of Ordinance 2011-1, as heretofore amended, shall remain unchanged.

<u>Section 6</u>. <u>Provisions Cumulative</u>. The provisions hereof shall be cumulative and in addition to any and all other taxing provisions of City Ordinances.

<u>Section 7</u>. <u>Severability</u>. The provisions of this Ordinance are severable, and if any part or provision hereof shall be adjudged invalid by any court of competent jurisdiction, such adjudication shall not affect or impair any of the remaining parts or provisions hereof.
