a. Facility repair and Maintenance

HVAC update: deadline was extended again, and bids have started coming in. They should have them all in by Friday, January 13th, 2023. Will come to the board at the February meeting. Regarding the humidity damage to the wall, Tiger will look back over whether the report stated anything about possible further damage.

Credit card fees – software issue, so the fees have not be added yet. Tiger will check into changing credit card companies. Pool was shut down for pump repair for a very short time. Issue was fixed much faster than anticipated.

b. Finance Report

Tiger handed out a finance report to the board members. Memberships went up a little bit. Facility rental is 5-Tool Basketball right now. Pool parties were down due to the holidays. The areas that brought revenue up were merchandise and guest passes.

Mayor handed out the November 30th, 2022 report. Talked through the fund balance. Riff asked why we keep so much money in "Cash?" Mayor stated that the City Treasurer could explain that better, and he will ask that question. Net revenue over expenditures is \$126,000.00 less due to repairs.

c. Aquatics Report

There were 11 public pool parties and 3 private. Chlorinator is down right now. Lifeguard training this weekend, which will bring in three more guards.

d. Personnel Report

e. Misc.

Took in 74 new members in December and were able to retain 83%. Jimmy the Elf – had over 100 people participate and had three winners. Wrapped up Maintain Don't Gain with 166 participants, and 98 maintained. Total weight loss came to 314 pounds. January Step-Up Challenge has 73 people participating. Silver Sneakers is now offered five days a week. Deep-water swim on Tuesdays. Working on locker clean-outs.
