#### 1. Call to order.

#### 2. Approve minutes of the April 5<sup>th</sup>, 2021, regular meeting.

Motion was made by Riff, second by Kemp to approve minutes of the April 5<sup>th</sup>, 2021, regular meeting. All voted yes.

3. Petitions from the audience. (Limited to 5 minutes, with advance reservation).

Pat Richard spoke regarding pickleball.

#### 4. Director's Report.

- a. Facility Repair and Maintenance
  - 1. The new sign will be installed next week.
  - 2. Awnings will be installed in mid-July.
  - 3. M&M Construction will be installing a new handrail for the ramp. Many people have requested it, especially those participating in water aerobics.
  - 4. A number of people comment on all the inspirational quotes around the Rec Center and have asked if they can put up even more. They have received a quote and will be putting more up for no more than \$200 or \$300.

#### b. Finance Report

Mayor Lees handed out a financial report to each board member. He spoke to the revenues/expenses. April has not been closed out yet, so there are some expenditures that are not reflected on this report. Approximately 60.6% has been spent so far. Mayor stated that his goal each month is to give them an overview. He will not be able to give them an accurate, up-to-date report because there is a lag time on financial numbers.

#### c. Aquatics Report

There is currently a waiting list of 26 people for swim lessons. Swim lesson revenue to date, is \$5,330.00. Jacki received her lifeguard training certification and can now train lifeguards. Five have been trained so far. They will be prepared to extend their aquatics hours, in case the outdoor pool does not get to open.

GRDA brought employees to train for water rescue. Inola brought their STEM classes and had boat races. Chouteau brought 150 children, who split between swimming and basketball and then switched. Ketchum and Turkey Ford will be there next week for end-of-school activities.

#### d. Personnel Report

They are getting Cherokee Nation worksite students to help around the facilities, inside and out.

#### e. Misc.

- 1. Received 118 new members in April.
- 2. In April there were 6,300 people through the door, which averages to almost 300 per day.
- 3. Long asked if the Board is ready to lift the Covid restrictions, to which they agreed.
- 4. Since the M/W/F water aerobics classes are so large, they plan to add T/Th classes as well, if the Board agrees. They had no problem.
- 5. Jerome reported that he has planted 2 4x16 raised garden beds with several different fruits and vegetables. It can be seen in the back. He plans to have the children pick the items when they are ready and teach them a little bit about farmer's markets and entrepreneurship.
- 6. Outdoor Fitness Court has passed through City Council. They are now seeking funding and are encouraged by the response.
- 7. The PDG design has been finished and we are now waiting on cost estimates.
- 8. The fishing clinic was held and had 63 participants. The children had so much fun. They plan to make this an annual event.
- 9. Hosted pickleball yesterday from 10 a.m. noon, but no one came. They are going to offer an evening event and see if it goes better.
- 10. The Health Department came to the Rec Center and gave out Covid shots. They will be back next month.
- 11. New T-shirts have been ordered.

## 2021-2022 Pryor Public School Contract

The **Pryor Public School After School Program** has the approval to utilize the PCRC facility and/or our instructors. The program will hold swim classes on Monday, Tuesday, and Thursday from 4pm until 5:30pm at PCRC during the months of Sept. and Oct., Nov. and Dec., Jan. and Feb., and March and April for a total of 83 visits. In addition, PCRC will partner with Pryor Schools on the Maintain Don't Gain holiday challenge. All Pryor faculty will have the opportunity to participate in this challenge. Participants will receive two InBody scans (accompanied with a detailed explanation of said scan by a PCRC employee) and will receive a tshirt for fulfilling the challenge requirements.

**Pryor Special Tiger Sharks Swim Team** will be utilizing the PCRC pool from September to May. The team plans to practice every Monday afternoon. PCRC and the Swim team head coach have spoken and she guarantees to have adequate coaches/volunteers at each practice to ensure a safe and productive environment. PCRC is also offering the swim team the option to schedule a second weekly practice if the coach deems it necessary.

This memorandum of agreement shall be effective only upon approval by the City Council.

#### FIRST AMENDED LEASE AGREEMENT REGARDING PRYOR CREEK RECREATION CENTER/BOYS AND GIRLS CLUB

**THIS AGREEMENT** is made and entered into by and between the City of Pryor Creek, Oklahoma (herein Lessor) and The Boys and Girls Clubs of Green Country, Inc., (herein Lessee) and shall be deemed effective upon the date of full execution by the parties hereto.

**WHEREAS**, the parties previously entered into that certain "Lease Agreement" dated the 6<sup>th</sup> day of September 2005, a copy of which is attached hereto as "Exhibit 1), and

WHEREAS, the parties are mutually desirous of amending the current lease agreement as herein stated.

**NOW THEREFORE**, the parties do covenant and agree to the amended terms of lease as herein stated with all terms of the parties' original lease remaining in full force and effect except as herein expressly modified and amended. Amendments to provisions of the lease as follows:

- LEASE OF PREMISES. Lessor hereby leases to the Lessee, and Lessee hereby leases from the Lessor, that portion of the building known as the Pryor Creek Recreation Center at the address of 1111 SE. 9<sup>th</sup> St., Pryor Creek, Oklahoma, set forth on the attached Exhibits "2" and "3" under the terms and conditions set forth herein.
- 5. CARE, MAINTENANCE AND REPAIR. Lessee shall not commit any waste or damage to the leased premises and shall have the duty of reasonable care to the leased premises. Lessee shall not be responsible for loss or damage to the Leased premises resulting from Lessor's use and occupancy or from occurrences covered by Lessor's policy of fire and casualty insurance. Lessor shall have the duty of reasonable and ordinary maintenance to the premises inclusive of such items as polishing floors, maintenance painting and the like, and to maintain the structural, mechanical, electrical and plumbing serving the leased premises in a reasonable and good condition.
- 6. ALTERATIONS. Lessee may make no alterations to the premises without the consent of the Lessor. All approved alterations will be made at the cost and expense of the Lessee, unless otherwise agreed by the parties, and shall conform in all respects to state and local laws, ordinances and regulations including without limitation the current edition of the City Building Code. Any alterations, additions or improvements Lessee has made to the Leased Premises shall become the property of the Lessor at the end of this or any subsequent lease term.

- 8. UTILITIES AND CUSTODIAL SERVICES. Lessor shall provide the following utilities at Lessor's cost to the leased premises: water, heat, air-conditioning, sewer, and electricity. Lessee shall provide at its cost routine custodial services of the premises.
- 9. ACCESS AND USE OF OTHER AREAS. Lessee's lease of the premises is confined to those areas set forth on attached Exhibits "2" and "3" together with parking areas in the premises parking lot reasonably necessary for Lessee's use of the leased premises. Lessee's use of additional areas of the Pryor Recreation Center may be made on a periodic basis on a permissive basis in Lessor's discretion and upon such terms and conditions of use as Lessor may deem appropriate.

In all other respects not specifically modified, or in direct conflict herewith, the parties' former lease dated the 6th day of September 2005 shall be and remain in effect.


