No action. Steve Powell provided a map of the area of concern, as well as a cost estimate for mill and overlay. The cost estimate comes to approximately \$250,000.00. This is not in our list of streets for this year's street project since it was brought to the city's attention after the list and budget were approved. Powell stated that the area could use some spot repair, which would be a help for now. He does not believe it is bad enough to require a full overlay at this point.

County Commissioner Darrell Yoder spoke, stating that he agrees this area needs repairing. He stated that he is willing to take care of the county's mile of overlay if the city will commit to the mile within city limits. He stated that it would cost approximately \$100,000.00 per mile.
